Nerilee couldn't get the Bluey yoghurt but she managed to get them now. The Bluey Box is a yoghurt, fruit, finger sandwiches with crust off and biscuits and cheese sticks.

7. Uniform Shop

We have stock of everything now except the polo shirts, Sarah has ordered what she thought would be half (about 350) but when she sent out the executive email (supplier thought she had 600 shirts worth of fabric). The supplier came back and said that's all the fabric used up so Sarah is just waiting to hear from them. She just order stuff in one order so and then we are going to have to look at something else or the price is just going to keep on going up on the faction shirts. Maybe we can put it out to the school community or brainstorm between the p and c and the school board. Sarah said maybe just do one plain colour shirt for factions as that's what other schools have (1 plain solid colour with the school logo on it). At the moment the faction shirt is predominant the same colour as the polo shirt so it can be worn everyday so the school board will have to decide moving forward (if we are going to decide to go one colour then will it be ok for the kids to wear them everyday, only on sports day or just on sports faction day.)

We should be able to get the polo shirts off the shelf, it may not be the same fabric and we may go down the same line as we have gone down before where people have complained about he quality but there is not much we can do.

Sarah will get prices from various suppliers like she has done before, if we are getting them off the shelf Sarah will put it out to different suppliers and see what she can get. There is no change in the main polo except we possibly will change the quality in the fabric.

Emma is still happy to do the orders once a week.

People can try on uniforms up in admin and we have stock so it should be ok and cover everyone that is waiting.

Helen mentioned maybe a new supplier of new shirt all together, Carla said maybe a new design. Helen will take these

ideas to the school board next week.

Chris Morgan who is the owner of Care for Kids (is letting us borrow their giant connect 4, giant shape things that kids can connect and make cubby houses – no giant jenga as kids got injured 2 years ago). We will have a pa that can play some music and just say thank you for being here and that its been put on by the p and c. Nerilee will supply a bubble machine.

Easter – Hot cross buns, Easter raffle (Ruth will be doing the whole event), Hat parade (Wednesday 29th March, Week 9) Mother's Day – Everything has gone up in price, maybe we need to do \$10 gifts and \$5. Maybe do a pre purchase or pre order. Kelly can mark on the envelope to clearly mark what the money is to spend on \$5 or \$10 gifts ect. Maybe a poll will be sent out that who will be willing to pay \$10 for a present.
